KEY FACTS

In 2021, data from Regulatory Authorities showed that in the UK there was 939,000 tonnes of hazardous soil and related wastes, of which 67% was classified under European Waste Classification (EWC) Code 17 05 03* (soil and stones containing hazardous substances) and 20% was classified under EWC Code 17 06 05* (construction materials containing asbestos).

CONSTRUCTION WASTE STREAMS

Augean operate two STCs at Port Clarence in Teesside and ENRMF near Peterborough. Our STCs are able to treat a range of hazardous soils contaminated with for example, metal substances, asbestos, hydrocarbons and high ph.

In addition to construction materials our STCs are equipped to treat the hard to handle wastes from process and industry, such as filtercakes, gasholder sludges and other highly contaminated oily wastes.

Underpinning **Augean's** treatment processes, is **Augean's** permitted hazardous waste and non-hazardous waste landfills. **Augean** has around 40% of the UK's permitted hazardous waste void.

Augean follows the waste hierarchy when assessing waste treatment solutions for:

- Hydrocarbon contaminated soils
- Metals contaminated soils
- Asbestos and asbestos contaminated soils
- Filter cakes and sludges
- PFAS contaminated soils
- Road plainings
- Contaminated dredgings
