

APCr is generated by EfWs, Biomass and Clinical Waste plants, as well as Hazardous Waste High Temperature Incinerators. The vast majority of APCr is lime-based, as opposed to sodium bicarbonate-based

By 2028 annual APCr tonnages are projected to rise to **around 770,000 tonnes**


