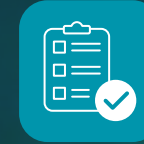

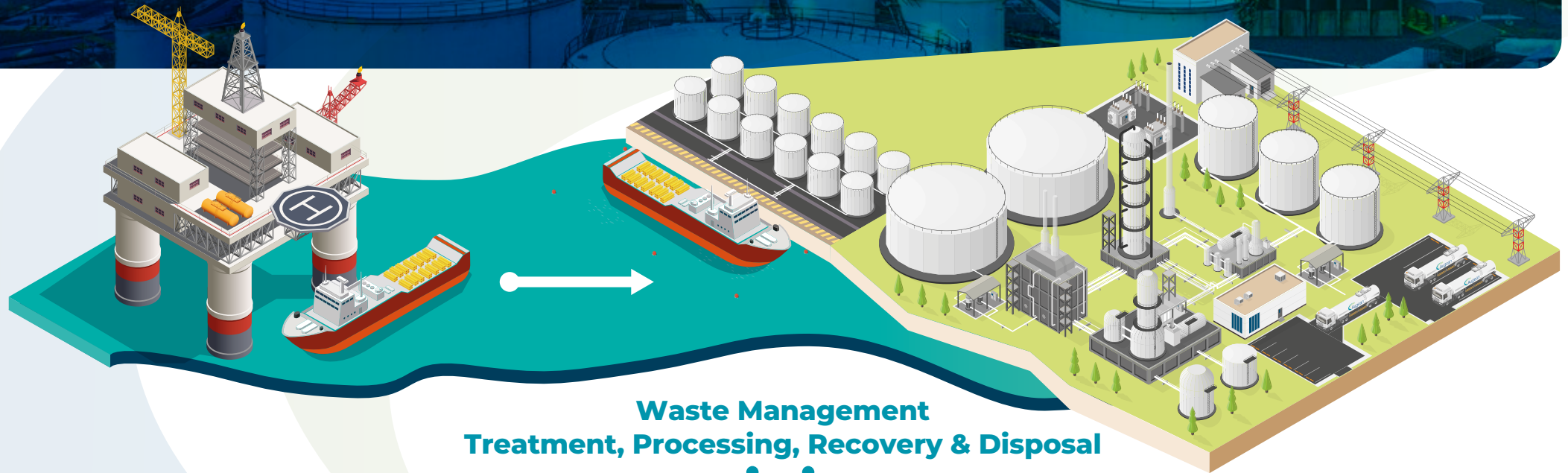

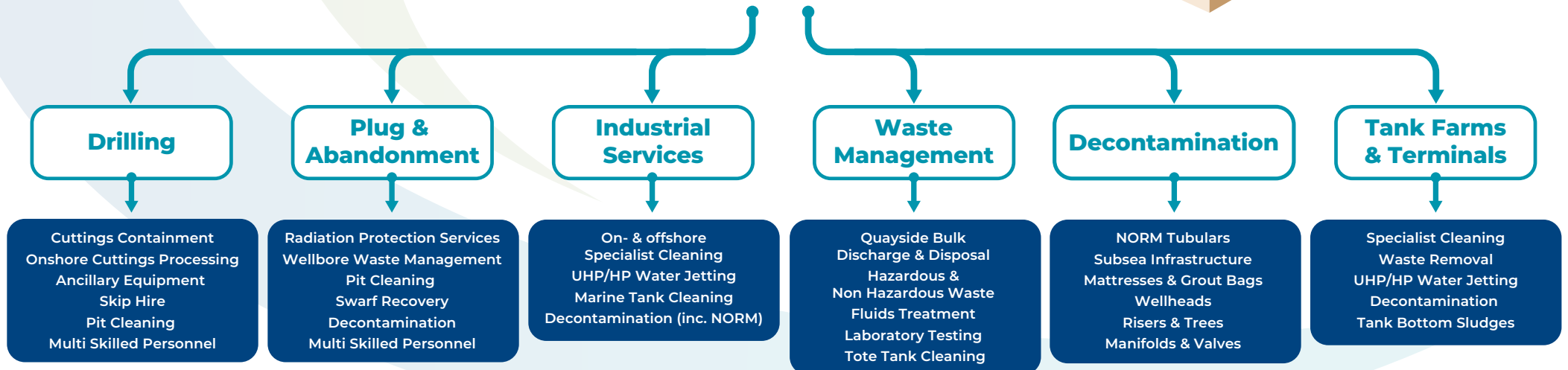

OUR SITES

Eco Centre, Peterhead

This state-of-the-art facility specialises in re-use and recycling of drilling waste streams. Specifically, it delivers highly optimised waste treatment processes for offshore drill cuttings and slops.



OUR TREATMENT PROCESSES:

- + Processing of drill cuttings / sludges via Thermo-Mechanical Cuttings Cleaner (TCC)
- + Slops separation
- + Chemical treatment of contaminated water
- + Fabrication / welding workshop
- + On-site laboratory
- + Handling and storage of mud / cutting skips

THE WASTES WE CAN TREAT:

- + Oil based drill cuttings
- + Oily Slops
- + Oily waters
- + Oily solids / sludges (non-crude)

Greenbank, Aberdeen

A fully bunded operational yard area where both hazardous and non-hazardous wastes are received and processed prior to onward transportation to one of our internal treatment sites or through Augean's network of third-party treatment / disposal points.

Blackdog, Aberdeen

Ideally located for servicing the Aberdeen and Peterhead harbour areas, our site allows easy access to waste recovery and disposal routes south of Aberdeen.

This site provides buffer storage for bulk liquid wastes received from our marine tank cleaning operations, and operates as a treatment and transfer centre.

- + Bulk powder handling
- + Specialist industrial cleaning
- + Industrial services (marine cleaning and terminals)

NORM Facility

Our fully permitted NORM site can accept, manage, and store all decommissioning wastes such as NORM contaminated tubulars and equipment from plug and abandonment, as well as sections of dismantled topsides and subsea structures along with NORM wastes including sludges, scale and PPE.

- + Accept, store and repack NORM waste
- + NORM decontamination
- + Processing and transfer of hazardous / non-hazardous waste
- + Waste and industrial service support for berthed rigs

Pocra Quay, Aberdeen

Our environmental award-winning site is a reception and treatment facility for wet and dry bulk wastes utilising the most up to date techniques for the treatment of drilling waste liquids.

The plant can receive deliveries of waste direct from the quayside in Aberdeen or via road.

- + Quayside reception of bulk powders
- + Vessel direct discharge for offshore slops
- + Slops separation

How Augean re-uses and recycles waste materials

Augean has in-depth expertise in sorting and segregating the wastes we receive before they move on to treatment and potential disposal.

With the waste hierarchy in mind, this allows us to identify the wastes that are ideal for re-use and recycling, therefore putting useful materials back into the supply chain.

By identifying the wastes that are recyclable we are able avoid disposal and positively contribute to the environment by reducing the need to extract fresh resources.

Key materials Augean reuse / recycle from within the Oil and Gas sector include metals retrieved from decommissioning and hydrocarbons recovered from waste, which are then re-entered to the supply chain where appropriate.
